

# Слава Ісусу Христу! Слава на віки!

This Communicator includes shares several important options for your parishes and we hope that your councils will have opportunity to review and discuss each of these items.

# 1) Utility contract for power and gas (response needed by February 16, 2024)

Five years ago, several of our parishes entered into a contract with Enmax for power and/or gas under a group rate. The billings were managed by individual parishes, but negotiated at a rate that was more favourable. We had 14 properties registered under the contract. This five (5) year term comes due at the beginning of March 2024, and we are once again researching and negotiating a new contract. This will be offered to those parishes currently on the plan, and to all other parishes in our Eparchy.

Our committee contacted a number of providers and compared rates and terms for each. It was agreed that for our parishes, we were looking for the best rate and for a term that would provide stability in pricing for our parishes. The recommended offering is as follows:

Electricity	5year Fixed	\$0.090040 / kWh
Gas	5 year Variable with fixed administration fee	Index + \$0.59/GJ

The utility contract will be with Emax Commercial where prices are based on a volume threshold. Another benefit of the commercial contract, should prices for electricity drop significantly, is the ability to renegotiate to a blended rate (i.e. (contract rate + current rate/2)). With gas, we would remain on a variable rate and could lock into a fixed rate if the market indicators recommend this. Such decisions would be made by the Eparchial Finance Council with consultation from our subcommittee.

For parishes on the current contract, you would have received a renewal notice from Emax offering a very high rate through their EasyMax. When we contacted Easymax their best rate for electricity was \$0.1229 (much higher than the rate we negotiated). Please respond if you are interested in once again participating in the joint contract.
